WHITE MOTOR CORPORATION—DELAY RESPECTING FARM MACHINERY DIVISION—MOTION UNDER S.O. 43.

White Motor Corporation's continued delays in reaching a decision to sell its farm machinery division is causing great hardship not only to the approximately 1,100 workers laid off in Brantford, but also to its Kelowna, B. HOUSING

CUTS IN SOCIAL HOUSING BUDGET—MOTION UNDER S.O. 43

Mr. Frank Oberle (Prince George-Peace River): Madam Speaker, I rise to move a motion under the provisions of Standing Order 43. Having regard to the fact that the government once again has misaligned its priorities in that commitments made respecting social housing programs have been betrayed, and that programs to which the government was committed under Section 40 of the Housing Act have never been delivered effectively in rural and northern areas of our country, and since energy and other input costs not considered by the program made it prohibitive for most northerners to participate, for whom the program was intended, I move, seconded by the hon. member for Simcoe North (Mr. Lewis):

That recent spending cuts in the social housing areas announced by the minister responsible for housing should not affect any programs that fall under Section 40 of the Housing Act and that such programs instead be strengthened in a manner which will account for the peculiar circumstances in the north with respect to high fuel and energy costs and other factors contributing to excessive and disproportionate living expenses.
