### REQUEST FOR REPEAL OF CHANGES TO UI REGULATIONS

#### DALY BUILDING

#### Question No. 261-Mr. Gauthier:

1. Has the Department of Public Works in any way disposed of its title to the Daly building and/or the Daly building site and (a) if so (i) by what means (ii) on what date (iii) to whom (b) if not, is any date projected for such disposal and, if so (i) by what means (ii) on what date (iii) to whom?

2. Is there any demolition and/or redevelopment schedule for the Daly building and/or the site and, if so (a) what demolition or redevelopment (b) on what dates (c) under what owner or lessee?

**Hon. Roch La Salle (Minister of Public Works):** 1. (a) and (b) The Daly building property is still owned by Public Works Canada. However, Treasury Board has approved the transfer of the property to the National Capital Commission. The Department of Justice will be requested to legally close the transaction.

2. NCC is looking for adaptive re-use of the building and has conducted a prequalification call which attracted 14 submissions. Six of these developers were then prequalified.

(a) NCC is now proceeding to Stage II of the proposal call, involving a request for financial proposals for the property. NCC considers that sufficient interest has been demonstrated to make retention of the existing structure possible.

(b) It is anticipated that financial proposals will be received by August, 1986, and that the necessary municipal and federal approvals will then be sought for a projected construction start of Fall, 1988.

(c) The selection of the lessee will depend on the outcome of the proposal call process.
