

any specific year since due to the severe drought in 1988 numbers from 1987 were also used. It includes not only expenditures by government, both federal and provincial, but also the estimated effect of support provided by other measures, including internal support, border protection and export competition measures. Of this \$8.8 billion estimate of total support, \$2.8 billion resulted from direct government payments, \$3.3 billion came from reductions of input costs (e.g., credit concessions, transportation subsidies, etc.) and general government services, (e.g., Inspection Services, research, etc.). The remaining \$2.7 billion was accounted for by market price support resulting largely from import controls in support of the supply management system.

Canada submitted this data in accordance with the Chairman's report and without prejudice to our negotiating position.

In accordance with the Chairman's report, all measures in use in the base period were included to provide the best possible "snapshot" of the situations in all countries. Participants will receive credit in the negotiations for programs eliminated or changed since then.

##### PROPOSED LOCATIONS OF EXPANSION TEAMS—GOVERNMENT POSITION

**Hon. C. William Doody (Deputy Leader of the Government):** Honourable senators, I have a delayed answer in response to a question raised in the Senate on October 23, 1990, by the Honourable Keith Davey, regarding National Hockey League-Proposed Locations of Expansion Teams—Government Position.

*(The answer follows:)*

To support an earlier response I gave to Senator Davey regarding expansion of the National Hockey League, I wish to table the following letter by the Minister of State, Marcel Danis, to the President of the National Hockey League, John A. Ziegler, Jr., as follows:

I understand that the NHL Board of Governors will be called upon to make a preliminary selection of three cities from among the candidates for franchises within the framework of a planned major NHL expansion as early as the 1992-93 season.

Several Canadian cities have indicated their interest in securing an NHL franchise, should expansion occur. Various media accounts have suggested, however, that a first phase expansion would consider applications from U.S. cities only.

Canadians have always had a passion for the game of hockey, and you are doubtless aware of the enormous contribution Canada has made to the development of hockey and of the NHL, not only in Canada but throughout the world. For many Canadians, hockey and the NHL are rooted solidly in Canadian history, a history which is

close to their heart, I would therefore ask you to ensure that this contribution is recognized so that the NHL Governors may be encouraged to give equal consideration to the Canadian cities which are candidates for expansion franchises.

Thank you for your consideration of this matter.

##### INDEPENDENCE OF FRENCH FORCES—RULES OF ENGAGEMENT—UNITED NATIONS SECURITY COUNCIL RESOLUTIONS—REQUEST FOR TABLING

**Hon. C. William Doody (Deputy Leader of the Government):** Honourable senators, I have a delayed answer to a question raised in the Senate on October 24, 1990, by the Honourable Allan J. MacEachen, regarding Independence of French Forces—Rules of Engagement—United Nations Security Council Resolutions—Request for Tabling.

*(The answer follows:)*

As requested by the Honourable Allan J. MacEachen the following are the Resolutions adopted from the United Nations Security Council. The full text of each resolution will now be tabled with the Clerk.

##### Resolution 660 (1990)

Adopted by the SC at its 2932nd meeting, on 2 August, 1990—Determined that a breach of international peace and security had taken place (i.e. that it was a legitimate issue for the Security Council); condemned the Iraqi invasion; demanded its withdrawal from Kuwait; and called upon Iraq and Kuwait to negotiate.

##### Resolution 661 (1990)

Adopted by the SC at its 2933rd meeting, on 6 August, 1990—Determined that Iraq had not complied with 660; affirmed the right of individual or collective self-defence; under UN Charter Chapter 7 called upon all states to impose strict economic sanctions on Iraq until it complied with 660 "but not including supplies intended strictly for medical purposes, and, in humanitarian circumstances, foodstuffs"; set up the 661 Committee (all UNSC members) to gather/provide information and advice on sanctions.

##### Resolution 662 (1990)

Adopted by the SC at its 2934th meeting, on 9 August, 1990—Decided that the annexation of Kuwait by Iraq is null and void and demand that Iraq rescind its declaration of annexation.

##### Resolution 664 (1990)

Adopted by the SC at its 2937th meeting, on 18 August, 1990—Demanded that Iraq permit the immediate departure from Kuwait and Iraq of third-country nationals and that Iraq take no action to jeopardize the safety, security, or health of such nationals; demanded that Iraq rescind its orders for the closure of diplomatic missions in Kuwait.
