CONCERNING CHARGES.

Mr. Hazen informed Mr. Currie that he would sup-port an investigation into the conduct of the sheriff of Restigouche if any charge of wrong doing were made. Mr. Currie had suggested that the sheriff, having been a candidate for the House, would be likely to favor his own party, and especially Mr. Mott, who has a large legal practice in that county. 



they can show a reasonable excuse for the omission. "Sec. 133. No person shall have an abatement unless he has filed with the Assessors the statement, under oath, within the time hereinbefore required; nor shall the Common Council in any such case, sustain an appeal from the judgment of the Assessors, unless they shall be satisfi-ed that there was good cause why the statement was not filed in due time as herein provided.






