Indianapolis, April 24.—By an order of Judge Joseph T. ## SOUTH BRUCE FARMERS ARE FOR RECIPROCITY

Big Meeting at Chesley Heartily Supports the Trade Agreement

Chesley, April 24.—In the opinion of this meeting the reciprocal trade arrangement now proposed will be an advantage to the citizens of every province of Canada and to all classes and callings.

An audience of over six hundred people, one-fourth of whom were Conservatives, enthusiastically carried the foregoing resolution at the close of a public meeting held here tonight.

Only two men voted against the resolution, and the meeting was held under the auspices of the South Bruce Liberal Association to give the people of Chesley and the farmers of the surrounding country an opportunity of hearing Hon. A. G. MacKay and Mr. H. H. Miller, M. P. for South Grey, discuss the trade agreement.

The hall of Chesley is a large one, but it proved to be entirely small for the crowd. Even standing room was at a premium, and many people were turned away from the landing outside.

Mr. Miller applied himself to the argument that American farmers would flood Canada with their produce, and showed in a ridiculous statement that it was not so.

By quotations, he made it clear, by quotations, that the principal object of the part of the United States in securing the agreement was to import foodstuffs from Canadian farms to relieve the high cost of living.

Mr. Miller declared that Ontario horse breeders would benefit by the operation of the agreement, since it would open up a new market in the Eastern States. He argued that it was only a matter of time when the Canadian West would be breeding its own horses, just as the Western States, which formerly imported horses, have now a surplus supply.

History of Reciprocity.

Hon. Mr. MacKay, after briefly setting out the history of both parties with regard to reciprocity, devoted his attention to a circular sent by a pork-packing company containing figures intended to show that Canadian farmers were now receiving more for their hogs than their American cousins.
