FINANCIAL AGREEMENT BETWEEN THE GOVERNMENT OF CANADA AND THE GOVERNMENT OF CHINA

WHEREAS the Government of China has requested the Government of Canada to make loans to the Government of China has requested the Government to purchase Canadian-produced goods for export to China;

WHEREAS by Order in Council P.C. 378 dated the fifth day of February, 1946, the Minister has been authorized under The Export Credits Insurance Act to make the loans hereinafter referred to, on behalf of the Government of Canada; and

Shih Shun, has been duly authorized by the Government of China to execute this WHEREAS the Ambassador of China to Canada, His Excellency Dr. Liu this agreement on behalf of the Government of China.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH that the parties hereto, in consideration of the mutual covenants and agreements heremafter contained, covenant and agree each with the other as follows:
