prepared to accept the services of dredging companies now charged, subject to safeguards. Is the minister in a position now to elaborate on that statement? What are the safeguards he has in mind at this particular time?

Hon. C. M. Drury (Minister of Public Works): Mr. Speaker, I would like to be in a position to say what the appropriate safeguards are, but discussions are currently taking place with the Ministry of Transport, the National Harbours Board, the Department of Justice as well as Public Works to try to determine what is both practicable and adequate.

Mr. Alexander: Can the minister advise whether he is having any discussions, with respect to the safeguards, with the companies which are now charged, and is it the intention of the government to advise the House and the public what these safeguards will be and whether in fact he will seek the approval of the House regarding these safeguards and the contracts before entering into them? I ask these questions because of the very serious nature of the matter and because of the peculiarity of the entire situation.

Mr. Drury: I think that I would probably be very glad to inform the House of the safeguards, but perhaps seeking approval of the techniques to be adopted, which I am sure will commend themselves to the House, would be a time-consuming procedure which would hold up effective work in this area.

Mr. Alexander: Mr. Speaker, a final supplementary. I can understand the predicament in which the minister finds himself, but I wonder if he could advise the House and the Canadian people what the safeguards are before entering into any contracts with the dredging companies, particularly those which are presently charged? Could the minister do that?

**Mr. Drury**: Mr. Speaker, there is really no great difficulty about that because the period between calling for tenders and entering into contracts is necessarily quite long.
