RIGHT OF EMPLOYEES TO STRIKE—MOTION UNDER S.O. 43

That this House condemns this dangerous trend of the government to encroach upon the authority of its own agencies; that this House condemns the federal government for attempting to remove the right to strike from public servants; that this House condemns the President of the Treasury Board for his continuous harassment of public servants at chambers of commerce meetings and through the media; and that this House recommends that the President of the Treasury Board seek to promote good will with government employees by initiating open and frank discussions with union leaders and by negotiating in good faith.
