MOTION UNDER S.O. 43

VISIT OF UNITED STATES PRESIDENT REAGAN—MOTION UNDER S.O. 43

Mr. Bill Yurko (Edmonton East): Madam Speaker, I rise under the provisions of Standing Order 43 on an important matter.

Every member in this House is pleased that the President of the United States of America is visiting Canada next week and will be addressing jointly members of this House and the Senate on March 11. Therefore, I move, seconded by the hon. member for Kingston and the Islands (Miss MacDonald):

That this House, through the unanimous passage of this motion, welcome President Reagan and wish him and his government well, and furthermore encourage him to meet with world leaders, particularly President Brezhnev, in the very near future to initiate negotiations for arresting aggression wherever it occurs in the world; to renew détente and establish a rationale for limiting the world's arms race and to reaffirm world peace and fundamental human rights as the first priority of international relations.

PRICING PRACTICES OF OIL COMPANIES—MOTION UNDER S.O. 43

ASTRA TRUST

CALL FOR PUBLIC INQUIRY—MOTION UNDER S.O. 43

Mr. Bob Rae (Broadview-Greenwood): Madam Speaker, I rise to move a motion under the provisions of Standing Order 43. Whereas eight people were charged yesterday with conspiracy to defraud the public of \$35 million in the collapse of Astra Trust and associated companies; and whereas the collapse of Astra was the first collapse of a federally-chartered financial institution since the depression; and whereas the justice committee of the Ontario legislature has determined that officials of Astra used political influence to gain their federal charter, I move, seconded by the hon. member for Hamilton Mountain (Mr. Deans):

That the federal government set up a public inquiry to determine why Astra received a federal charter, how it operated, why it collapsed, who was responsible, what compensation should be paid to its victims, and ways of ensuring such a collapse is not repeated.
