When a company decides, as the Iron Ore Company of Canada did, to take all the profits that it has made, all the benefits it has received from Canada, and move it away to another part of the world and set up a new operation, when the President of that company finally makes his decision to close it down and disrupt an entire community and throw people out of work-a President, incidentally, who may well be a leadership candidate for the Tory Party-when he decides to do those kinds of things, I do not hear screams and shouts from the backbenches of the Conservative Party demanding equity and fairness for the employees, demanding that the company be forced to live up to its obligations to Canada and to its employees. When International Nickel rapes an entire community for years and takes money off to South America and other places, money made in Canada, and then cuts the prices which normally would be received by the Canadian operation, and then gradually reduces the work force by 25 per cent, 30 per cent, 35 per cent and 40 per cent over time to the point where it will shut down totally, I do not hear the Tories or the Liberals standing up and saying: "By God, we expect that company to live up to its obligations and provide employment for those people and safeguard those communities." But when some employees, acting in their own best interests, decide that they must withdraw their services, the economic consequences of which they are prepared to accept, then, by God, the Government and the Tories together are quick on their feet to send them back to work.

I say to the labour critic for the Conservative Party that I would like to see where the Tory Party policies are which say that companies have no right to shut down plants and throw people out of work. I would like to see them talking about the obligation those people who have taken from this country have to put something back into it. I would like to see where the Tory Party's obligation is concerning a guarantee that there will be no dislocation of employment as a result of management decisions taken in the best interests of a few to relocate in another part of the country or the world, this without any concern for the interests of the workers or their communities. No. all I can see is the obscene haste on the part of both these Parties to pick on the working people of Canada constantly as though somehow or other they were there simply to be picked on. I see both of these Parties failing to put in place the proper procedures to encourage collective bargaining, failing to provide the necessary support, which is absolutely fundamental to good collective bargaining. I fail to see the position of the Government and the Conservative Party with regard to the fact that if employers are going to have the right to lay people off, shut things off and close things down in their economic interest, employees concurrently should have the right in their economic interest to decide to withhold their service until they are able to find a reasonable and satisfactory resolution to their dispute. This has not happened.
