**Mrs.** Collins: Given the increasing numbers and rates of arrivals in this manner would the Minister consider imposing a visa requirement on Honduras in order to deter those who might seek to come to Canada through the refugee process when in all fairness they should be applying through the regular immigration process?

Some Hon. Members: Hear, hear!

Hon. Benoît Bouchard (Minister of Employment and Immigration): Indeed, Mr. Speaker, I have been advised that the number of people arriving in Vancouver from Honduras has doubled, particularly over the past two and a half months. Quite obviously we are facing the kind of situation we experienced last year in Toronto and Montreal, and we are seriously considering imposing a visa requirement in the near future. If the number of arrivals does not decline we will certainly consider the possibility of imposing visas on Hondurans.
