Could I call on the Prime Minister to order his minister of fisheries to come to the aid of Newfoundland plant workers and fishermen who need more money, to provide programs for them that they badly need and rightly deserve?

Hon. John C. Crosbie (Minister of Fisheries and Oceans and Minister for the Atlantic Canada Opportunities Agency): Mr. Speaker, in connection with this program, this program has provided funds to assist fishermen affected by catch failure wherever they were in Atlantic Canada, including Nova Scotia. The lion's share, if we might call it that, of the assistance has gone to Newfoundland and Labrador because this was the main area of catch failure.

For example, in connection with funding provided for 14,000 additional tonnes of herring to be purchased to give more work to fishermen and fish plant workers, 10,000 tonnes of that was allocated to Newfoundland and 4,000 to Nova Scotia and New Brunswick. We are trying to be as fair as we can be.

The Prime Minister of course is heavily in favour of assistance to anyone living anywhere in Canada where there is a demonstrated need, as the actions of the government have shown.

Mr. Speaker, my question is for the right hon. Prime Minister. For 50 years the Lubicon Lake Indian band has been trying to settle its land claims. The Minister of Indian Affairs and Northern Development has said he is committed to resolving this claim.

Why then have there been no negotiations with the Lubicon Cree since 1989, and can the Prime Minister explain why the Minister of Indian Affairs and Northern Development created and funded last year a new band in the area claimed by the Lubicon band?

Hon. Shirley Martin (Minister of State (Transport)): Mr. Speaker, I appreciate the hon. member's ongoing concern on this particular issue, just as the Minister of

Indian Affairs and Northern Development also has a concern.

We have been working with the bands to try to reach an agreement on this.

Mr. Kilgour: Baloney.
