Reims, Sept. 4.—The fifth week of the court-martial of Captain Dreyfus began to-day with the largest attendance yet seen in the Lyceum. The interest in the trial grows as the denouncement approaches. Six to ten days is given as the outside limit for the further duration of the trial. There were an exceptionally large number of ladies present to-day, their bright costumes giving a gay look to the court.

The session opened very interestingly with the appearance of the witness, M. Gernuschi. He was dressed in a brown lounge suit. His features are unprepossessing, and in fact his general appearance is very little credit to the Serbian royal house, to which it is alleged that he belongs. His letter to Col. Jouannet, which was read, was in French, and M. Labori stated that, having been mixed up in political troubles in Austria-Hungary, he has been obliged to seek refuge in France, where he has a friend who has a high official position in the French government.

## SELF-DEFENCE OF THE NEWS

### YACHTING PARTY OF ELEVEN MET DISASTER WHEN THE CRAFT WAS DISMISTED IN THE GALE.

Brave British Naval Officers Saved Two Lives, as Well as Their Own, But the Rest of the Occupants Went to Death.

Halifax, N.S., Sept. 4.—A terrible accident, resulting in the loss of seven lives, occurred off the coast of Nova Scotia to-day. The victims were members of a yacht party, which left here this morning in a yacht hired for the occasion. Their destination was McNab's Island, a popular resort about two miles from the city. The boat reached its destination in safety, and the pleasure-seekers spent an enjoyable day.

**Eleven in the Party.**  
The party included Robert Davison, aged 25, his wife, 23, his sister Mabel, 12, Florence, 22, Alice, 24, Bertha, 24, and Louise, 23, William H. Hamilton of the city clerk's office, 29, John Hancock, 30, J. Poole and Edward Judd, officers of H.M.S. Talbot. The Davisons were children of Robert Davison, who came here from New York seven years ago, and is one of the best known residents of this city.

**How Disaster Occurred.**  
About 5 o'clock the party went to return home, with a strong wind blowing from the north. The breeze freshened until it was a gale, and the boat was tossed and heavy seas followed one after the other in quick succession. It was one of the most dangerous sailing days that have been experienced here for some time, and when the boat was in one of the most dangerous parts of the eastern coast, with all sail set and tore the mast from its base. A second gale forced the heavy timber back, and striking the mast from a capstan hole through the bottom.

**Seven Were Drowned.**  
In a moment the party were face to face with death, and the eleven were battling for their lives. Poole and Judd, who are both excellent swimmers, caught Bertha and Louise Davison in their arms and started for shore. The others were left to their fate.

**Mr. Davison Was the First to Disappear beneath the waves, and one after the other the bodies floated ashore.** For nearly a quarter of an hour the brave officers fought against terrible odds, and were at length picked up by a passing steamer. The women were almost gone, and it was only after much attention that they were resuscitated.

**The news was telephoned to the city, and Mayor Hamilton at once detailed a squad of policemen to proceed to the scene of the disaster, and endeavor to recover the bodies.** At 10:30 p.m. that of Alice Davison was brought to the surface, and removed to a farm house at the eastern end of the city. By morning it is expected that the others will be recovered.

## CLAMOR OF THE LIBERALS A BIG CONSERVATIVE RALLY
