ARGENTINA MAY HELP CASTRO. NEW YORK, Dec. 15.—The Herald correspondent in Caracas says he has learned that reliable authority that the government of Argentina, in a dispatch from Buenos Ayres, has instructed its consular representative to report to the Argentine government as early as possible what appears to be the attitude of the United States and what view that government is likely to take of its obligations under the Monroe doctrine in the event of the aggressive action of Great Britain and Germany in supporting the United States to remain impassive on the ground that its interpretation of the Monroe doctrine does not interfere with foreign powers respecting the claims measures for the collection of debts, the correspondent says he is informed that the government of Argentina, feeling that the autonomy of the South American states is jeopardized, is prepared to take a decided stand by the side of Venezuela and to offer her assistance to President Castro.

Disposal of Manchester's Amendment to Educational Bill. Houses May Join Issue—Lower Always Claimed Sole Privilege of Raising Supplies from the People—Ancient Limits Ignored.

(Cor. N. Y. Herald.) LONDON, Dec. 14.—The amendments made by the House of Lords in connection with the Education Bill are not numerous. Very few of them are important, but as one at least, if not two, seem to infringe on the exclusive rights of the House of Commons it is possible that there may be rather a lively debate when the bill goes back to that house on Tuesday next.

The majority of the peers present on Wednesday night, including 18 bishops, amendment which makes the local authorities liable for keeping denominational schools in good repair.

OBJECT OF THE CLERGY. Their object is to get their own schools provided for them gratuitously out of the rates and taxes, while refusing on behalf of the church, but of the clergy, to surrender clerical control.

The Kenyon-Stancy clause, as modified by the lords, does not altogether obscure, but it is still ambiguous and the intention of the lord chamberlain will enable the whole body of the local managers, or the majority of them, to prevent a clergyman teaching religion in the schools, and on appeal to the bishop of the diocese, is authorized to do so by a trustee, dependent on the specific question whether the school is a day school or a boarding school.

How such a clause, if not further amended by the commons, will work in practice is beyond the power of any lawyer or layman, to predict. One thing is certain—it will raise a fine crop of lucrative litigation for the gentlemen of the long robe.

On this point, however, the lords are clearly within their rights.

RAISES QUESTION OF PRIVILEGE. The Bishop of Manchester's amendment dealing with the liability for repairs raises the question of privilege, for if the managers are not liable to the local authority in this respect, they have added to the public burden.

Ever since 1671 both houses have accepted the principle, then laid down by the commons, that "the right of granting aid and supplies to the crown should be in the commons alone as an essential part of their constitution, and the limitation of all such grants as to matter, manner, measure or time is only to them."

Although this resolution applies in its terms to taxes and not to rates, successive speakers, including the late speaker, now Lord Peel, have held, as regards the privilege of the commons, that there is no difference between rate and tax. Both are charges upon the people, and though rates are not directly imposed by the commons, the power of imposing them can be derived from no other source.
