other weighty reasons, the Petitioner prays the House to take the subject into immediate consideration, and grant such redress as will insure him a seat in this Honorable House.

Resolved, That the House will, this day, at two o'clock, take into consideration the subject matter of the Petition of John Frederick Holland, Esq. complaining of an undue Election for the Town and Royalty of Charlotte-Town.

Ordered, that the said John Frederick Holland Esq. the petitioning Candidate, have notice to attend at the time appointed for taking the said Petition into consideration, in order that he may be heard, by himself or Counsel, in support thereof.

Ordered, that the Colonial Secretary have notice to attend at the hour above mentioned, with the Poll Books and Writ of

Election.

Ordered, that Mr. John C. Sims, the Returning Officer, and the Poll Clerks, have also notice to attend at the same hour.

The Order of the Day, for the House in Committee on the Bill to extend the Jurisdiction of Commissioners in matters of Small Debt, being read;

Ordered, that the said Order of the Day be

postponed until to-morrow.

The Bill for the Conviction and Trial, in a summary way, of persons committing Common Assaults and Batteries, was, according to order, read a second time.

Mr. Secretary Collins was admitted within the Bar, and delivered to Mr. Speaker, from His Excellency the Lieutenant Governor, the Copy of a Despatch from the Right Honorable E. G. Stanley, His Majesty's Principal Secretary of State for the Colonial Department, transmitting Copies of two Orders in Council, passed by His Majesty in Council, on the 7th December, 1829, approving of certain Acts passed that year by the Legislature of this Island.

And the said Despatch and Orders in Council, were read, as followeth:—

As there appears to be some reason to apprehend that Two Orders in Council, passed by His Majesty in Council, on the 7th December, 1829, and approving certain Acts of the Legislature of Prince Edward Island, have not reached the Colony, I have the honor to transmit herewith Copies of the same, in order that you may be apprized of the pleasure of His !

Majesty in Council, with respect to the Acts referred to in these Orders.

Whereas, the Governor of His Majesty's Island of Prince Edward, with the Council and Assembly of the said Island, did Pass 19 Acts, in the Months of March and April last, which Acts have been transmitted, Intituled as follows, viz :-

"An Act to regulate the laying out and altering of Highways, and to provide a mode of obtaining Compensation for those who may thereby be injured, and to cause those who are benefited thereby to contribute towards

their formation."

"An Act for the Security of Navigation, and for pre-serving all Ships, Vessels and Goods, which may be found on shore Wrecked or Stranded upon the Coasts of this Island, and for Punishing persons who shall steal Shipwrecked Goods, and for the relief of persons suffering loss thereby."

"An Act for keeping clean the Streets of Charlotte-Town, and for removing Obstructions therefrom."

"An Act for the appointment of Limits and Rules for the Jail of Charlotte-Town."

"An Act to amend an Act made and passed in the Ninth year of His present Majesty's Reign, intituled, An Act for Establishing the Standard Weight of Grain and Pulse, and for appointing proper Officers for Measuring and Weighing the same."

"An Act to alter and amend an Act, made and passed in the 31st year of the Reign of His late Majesty, intituled, An Act for compelling persons owning Lands ad-joining each other to make their respective parts or proportions of the Fence between them, and for empowering the Grand Jury to nominate Fence Viewers."

"An Act for encouraging the Fisheries by granting

Bounties.'

"An Act to regulate the size of Barrels and enforce the Inspection of such Pickled Fish as may be exported from Prince Edward Island.

" An Act to regulate the Introduction of Passengers in

Vessels arriving in this Island."

"An Act for the Establishment of an Academy in Charlotte-Town."

"An Act to amend an Act, intituled An Act to render perpetual an Act, intituled An Act to enable the Justices of the Supreme Court of Judicature to issue Commissions for examining Witnesses out of this Island.'

"An Act in further amendment of an Act made and passed in the 6th year of the present King, intituled, An Act to regulate the performance of Statute labour on the Highways, and to suspend an Act made and passed in the 35th year of the late King, intituled An Act to alter and amend the High Road Laws."

"An Act to indemnify the Treasurer of this Island, and all other persons concerned, in paying certain Monies on Warrants issued since the last Session of the General

Assembly."
