ANSWERS TO QUESTIONS

The following answers, deposited with the Clerk of the house, are printed in the official report of debates pursuant to standing order 39:

MR. DACOUGNA, FRENCH GUIANA— IMMIGRANT STATUS

Question No. 124-Mr. Argue:

1. Was Mr. Dacougna of French Guiana, who sought entry to Canada on September 22, 1960, considered to be a non-bona fide immigrant or non-immigrant?

2. If so, on what grounds?

Answer by: Hon. Ellen L. Fairclough (Minister of Citizenship and Immigration):

1 and 2. Mr. Dacougna was ordered deported on the grounds that he was not, in the opinion of the special inquiry officer, a bona fide non-immigrant. (See section 5(p) of the Immigration Act.) At the time of his arrival in Canada he had insufficient funds to maintain himself for more than a few days. He gave several different reasons for coming to Canada, including one that he was seeking medical treatment (for which he did not have the funds to pay), and another that he was intending to marry a resident of Canada. His intended fiancée was known to him only through correspondence. Two previous applications for his permanent admission to Canada had been refused, on the grounds that he did not come within the admissible classes of immigrants whose admission is authorized by the Immigration Act and regulations. From the evidence given at the inquiry, the special inquiry officer came to the conclusion that, if Mr. Dacougna were allowed temporary entry to Canada, he might then seek to remain here. On these grounds, since Mr. Dacougna was not in the opinion of the special inquiry officer a bona fide non-immigrant, deportation was ordered.

The yards are being constructed to provide faster and better service to customers through greater efficiency in operations with the objective of producing increased railway traffic volume, which would, of course, maintain or enlarge employment opportunities. As each yard nears completion, yard masters, yard foremen, switch tenders and clerical forces are being retrained in the new skills required. When the yards are fully operational, adjustments will occur some of which will be taken care of by normal attrition. At the same time, retraining measures are being undertaken to provide, wherever possible, alternate employment. Therefore, the displacements which may actually occur are not immediately ascertainable.
