### CRITERIA TO INDICATE POLITICAL AFFILIATIONS

#### Question No. 876-Mr. Caouette:

- 1. Under what criteria does the chief electoral officer indicate political affiliations in the list of candidates established for the armed forces?
- 2. Does the chief electoral officer forward instructions to the returning officers in order that all provisions of the electoral expenditures legislation be complied with and, if not, what is the reason?

Hon. Judy V. LaMarsh (Secretary of State):

1. The criteria under which the Chief Electoral Officer indicates political affiliations in the list of candidates established for the armed forces are from the best sources of information available to him, as prescribed by subparagraph (3) of paragraph 16 of The Canadian Forces Voting Rules in Schedule II to the Canada Elections Act.

2. Subsection (1) of section 60 of the Canada Elections Act provides for the governor in council establishing a tariff of fees, costs, allowances, and expenses to be paid and allowed to returning officers and other persons employed at or with respect to elections held under the said act. At such time as an election is called, special instructions are sent to all returning officers regarding any expenditures to be made by them pursuant to the said tariff of fees.

(a) 38.296 cents per bushel; (b) 38.711 cents per bushel; (c) 36.228 cents per bushel; (d) 36.888 cents per bushel; (e) 44.022 cents per bushel; (f) 46.426 cents per bushel; (g) 47.638 cents per bushel.

## STATUTORY RESERVE BY CHARTERED BANKS Question No. 899—Mr. Hees:

- 1. Do the chartered banks maintain a statutory reserve of 8 per cent on Canadian dollar deposits in cash and/or deposits with the Bank of Canada?
- 2. What was the amount of their aggregate deposit on their fiscal year ended October 31, 1965?
- 3. Does the Bank of Canada pay chartered banks any interest on these deposits and, if so, at what rate?

Hon. Mitchell Sharp (Minister of Finance):
1. Section 71(1) and (2) of the Bank Act prescribe the cash reserve in the form of a deposit with the Bank of Canada and of Bank of Canada notes held by the bank which each chartered bank is required to maintain. The percentage in question is 8 per cent.

- 2. Aggregate chartered bank deposits with the Bank of Canada on October 31st, 1965, were \$1,018,157,106.
