Mr. Pierre De Bané (Matane): Mr. Speaker, pursuant to Standing Order 26, I move the adjournment of the House to discuss a specific, important and urgent matter.

This specific and urgent matter is the deci-Privy Council): I will make a further inquiry sion of the CRTC to issue a great number of Télémédia under circumstances and for considerations which, as admitted by the CRTC itself, are absolutely inconsistent, in addition to the concentration problems involved.

> The urgency arises from the impending adjournment of this part of the session and from the 60-day delay allowed the governor in council to rescind that CRTC decision. Besides, my request is seconded by the chairman of the Standing Committee on Broadcasting, Films and Assistance to the Arts.

> Mr. Speaker: The hon. member for Matane filed the notice provided for in Standing Order 26, which has given me the opportunity to take the request into consideration.

> Hon. members will readily admit that the problem raised by the hon. member for Matane (Mr. De Bané) is one of real importance and general interest. It also has an aspect of urgency since the House will probably recess very shortly.

> However, does this justify adjourning today's proceedings in order to study the matter brought up by the hon. member? It is questionable.

> May I suggest to hon. members that the decisions taken by commissions while carrying out their normal functions should not constitute matters for urgent discussions. Even under the circumstances which seem to cause the hon. member some concern, it would seem to me difficult to justify the adjournment of our proceedings to allow interested members to express their views. I would point out to the House that if the CRTC decision was only made public recently, the problem itself has been discussed and commented, even in a controversial manner for several months, so that hon. members have had many occasions to express their views and present arguments for and against the project in question.

Under the circumstances, I must decide that the hon. member's motion cannot be put today.
