Rosenberg who rented the Argyle Street building to the Department of National Health and Welfare and the following year went to work for Mr. Rosenberg, may I ask the minister whether he caused an inquiry to be made into this whole matter and, if so, is a report available to be tabled in the House?

AID TO AFRICAN NATIONS SUFFERING FROM DROUGHT— MEASURES TO ENSURE DISTRIBUTION OF FOOD TO REMOTE AREAS

In view of the persistent reports that many Frenchspeaking countries of Africa are suffering from extreme starvation, what new action is the government taking or does it intend to take to bring relief to those countries?

Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, in answer to questions on the same subject in recent days I have said that the Canadian government has approved the expenditure of several millions of dollars to provide food for the countries on the rim of the Sahara that are suffering from unprecedented drought. The Department of National Defence has provided Hercules aircraft to fly supplies to places that are distant from ports. I believe that the president of CIDA, Mr. Gérin-Lajoie, will personally be there to investigate the situation.

OLYMPIC GAMES, MONTREAL, 1976—REQUEST FOR STATEMENT ON FINANCIAL ASPECTS BY PRIME MINISTER
