

\$218,353. (c) Printing was done in Montreal by Gazette Printing Company through Cockfield Brown Inc. (d) Eight million copies of the pamphlet are being distributed as a print insert in eight national magazines (French and English); in October, *Today/Perspectives*; *Reader's Digest/Sélection du Reader's Digest*; and in November, *Chatelaine/Châtelaine* and *TV Guide/Hebdo*. Cost of distribution is estimated at \$163,000. Distribution of additional copies will be done through programs within the department and in conjunction with other federal, provincial and local agencies.

2. (a) "Canada's Food Guide" is a one-page nutrition education tool developed through collaborative federal-provincial efforts. Since 1977, over eight million copies of the Guide have been distributed largely in co-operation with provincial departments of health. In addition, information on Canada's Food Guide is expanded as needed, in teaching and information materials such as booklets, pamphlets and posters prepared by many agencies.

(b) Canada's Food Guide was not distributed at the same time as the pamphlet, since the pamphlet was designed to promote only the variety aspect of the Guide. The circle representing the four groups was included to remind the target group, young adults, of Canada's Food Guide which has been available to them for many years. In addition, distribution costs would have increased and it would have duplicated existing information.

3. The pamphlet "Eat Better, Feel Great" is directed to young adults, 18 to 34 years of age, to encourage them to look at their own eating habits and consider changes. This can aid in preventing some of the overweight and poor nutrition habits in later years. Many programs across the country deal with the younger child but few exist which are related to the young adult target group. This group serves to bring about change in the food habits of children. The pamphlet will, of course, be read by others including the older age group and will help those who eat too much salt or fat. There are nutrition programs within the department which address problems such as overweight.

4. (a) The "Eat Better, Feel Great" pamphlet is part of a national awareness program to promote health. It is designed to stimulate Canadians to examine their personal eating habits and to make positive changes. It is based on nutrition research in both scientific and applied health fields and was developed to implement the nutrition recommendations for Canadians.

(b) "Canada's Food Guide" was designed as an educational tool for working with the public or in student training. It is used by health workers, teachers, counsellors, the food industry and the media in presenting a sound and consistent mes-

sage. It has been evaluated and is revised as required to best reflect recent scientific research and general eating patterns of Canadians. It is an example of successful collaborative efforts between federal and provincial governments.
