MEASURE TO AMEND

The House resumed consideration of the motion of Mr. Crosbie that Bill C-49, an Act to amend the Criminal Code (prostitution), be read the second time and referred to the Standing Committee on Justice and Legal Affairs.

Mr. Don Boudria (Glengarry-Prescott-Russell): Mr. Speaker, I will be brief because I want to conclude my remarks today. It has been said by some that prostitution is a victimless crime. I beg to differ with that comment. I believe the prostitute herself is a victim of the crime because the prostitute is generally controlled by others who place the prostitute in a position of quasi and even outright slavery. The attitude of the Minister of Justice (Mr. Crosbie), who has decided to remove the enslaved from the public view and believes that that is somehow a solution to the problem, is very inadequate. I do not think it is right. None of us should be participating in any way to give this Minister the approval of the Bill. I cannot support this kind of legislation.
