GOVERNMENT'S ANTI-DRUG ABUSE STRATEGY

Mr. Ken James (Sarnia—Lambton): Mr. Speaker, drug abuse in both schools and the workplace is a serious concern. In my constituency a group known as the Lambton Families in Action has been fighting this problem through a program of information and education since February, 1982. To this group, our Government's commitment in the Throne Speech to bring forward a national drug strategy was reason to celebrate.

REGIONAL DEVELOPMENT

NORTHERN ONTARIO—GOVERNMENT'S ECONOMIC RECOVERY PACKAGE

Mr. Keith Penner (Cochrane—Superior): Mr. Speaker, my question is directed to my hon. friend, the Deputy Prime Minister. On several occasions in the recent past he has boasted in this House about the good things the Government has in store to help the faltering economy of northern Ontario. We welcome good things from any source. Is the Minister willing and able today to tell the House exactly what is in the recovery package for northern Ontario which was alluded to following a Progressive Conservative caucus meeting in Sudbury just a few weeks ago?

Hon. Don Mazankowski (Deputy Prime Minister and President of the Privy Council): Mr. Speaker, I would be glad to do that. First, this Government has recognized the difficulties in northern Ontario, the uniqueness of the region, and there are at least seven possible initiatives at which we are looking. They are to establish a federal economic development committee for northern Ontario, to transfer some federal agencies and services related to northern Ontario, to dedicate program moneys to northern Ontario, to establish a stabilization program for forestry and mining, to invest in northern Ontario schemes, to give special tax treatment to equity investors, to strengthen marketing assistance companies in the region and to encourage development of a strategic partnership.
