Mr. Fernand Robichaud (Westmorland—Kent): Mr. Speaker, today I have the honour of tabling five petitions from the province of Nova Scotia and more specifically from the people of Fall River, Halifax, Windsor Junction, Dartmouth, Bedford and Sackville.

# REQUEST TO WITHDRAW TARIFF ON ENGLISH LANGUAGE BOOKS

Caccia (Davenport): Mr. Speaker, taking your earlier admonition fully into account I will submit a group of petitions signed by 170 residents of Windsor, Amherstberg and vicinity who ask the Government to rescind the book tariff for the very simple reason that it penalizes the Canadian consumer, book publishers, book sellers, book distributors and Canadian culture as a whole.

#### OPPOSITION TO PROPOSED EXCISE TAX

Hon. Lloyd Axworthy (Winnipeg—Fort Garry): Mr. Speaker, I have the privilege of presenting a very extensive petition from residents of Winnipeg, Fisher Branch, The Pas, St. Boniface, Ashern, Lauder, Eriksdale, Gimli and other points in Manitoba. There are 1,250 names in total. The petition has been certified by the Clerk. It reads as follows: Whereas a cabinet committee of the federal Government is considering a special excise tax on goods used by the consumptive users of wildlife, hunters and fishermen; guns, ammunition, rods, reels, lures, and on the nonconsumptive users as well such as canoeists, backpackers, campers and birdwatchers to name a few, wherefore the undersigned, your petitioners, humbly pray and call upon Parliament to halt this proposal immediately.

# OPPOSITION TO CUT-BACKS TO RESEARCH, SCIENCE AND TECHNOLOGY

Mr. Howard McCurdy (Windsor—Walkerville): Mr. Speaker, it is my pleasure to table a petition signed by a number of citizens of Canada who are exercising their right to do so. They protest the cut-backs of the National Research Council. They ask that those cuts be rescinded and demand that the Government act on its commitment to increase the rate of expenditure for research, science and technology to 2.5 per cent of the Gross National Product.

### OPPOSITION TO PROPOSED CHANGES TO PATENT ACT

Mr. Howard McCurdy (Windsor—Walkerville): Mr. Speaker, I have a petition signed by a number of Canadian citizens, exercising their right to do so, expressing their concern about the concession to United States interests represented by legislation being introduced which would have the effect of raising the price of drugs in this country. The petitioners demand that the Government withdraw this legislation and give consideration to a more appropriate approach to patent policy.
