ENVIRONMENTAL AFFAIRS

FUNDS AND MANPOWER NEEDED TO ENFORCE NEW LEGISLATION'S PROVISIONS

Hon. Chas. L. Caccia (Davenport): Mr. Speaker, the environment protection Bill introduced in the House by the Minister of the Environment (Mr. McMillan) on Friday looks good on paper as far as it deals with new chemicals. However, no matter how well written, it cannot stop pollution without monitoring and enforcement.

To implement the Bill the Government has allocated only \$37 million over five years to be split between three departments, the Department of the Environment, the Department of National Health and Welfare and the Department of Justice. This \$37 million is further divided between assessment of new chemicals, administration of the Act, and enforcement.

In addition, in 1987 the Department of the Environment has already lost 106 person-years and the Health Protection Branch of the Department of National Health and Welfare has lost 22 person-years. In the face of these facts, how can the Government ensure effective enforcement?

How can the Government impose \$1 million a day fines without the means to enforce the law? To be convincing, the Minister must make adequate funds available for enforcement if this Bill is really going to protect the environment and Canadians.

CANADA LABOUR CODE

MATERNITY BENEFIT PROVISIONS

Mr. Rod Murphy (Churchill): Mr. Speaker, it is always a rush in the House at the end of June to pass legislation. As a result, quite often we do make mistakes in the passage of legislation and such an occurrence took place in 1984 when we made changes to Part III of the Labour Code. At that time we tried to guarantee that women who were on maternity leave, who would normally be receiving benefits paid by their employer, would continue to receive those benefits. Since then we have had a decision rendered in a case with regard to Bell Canada where the opposite has been decided.

Since Labour Canada promised the women of this country they would continue to receive paid benefits while they were on maternity leave, I call upon the Minister of Labour (Mr. Cadieux) to keep that promise and to act quickly to ensure a legislative change is made.
