**AGRICULTURE****SPECIAL CANADIAN GRAINS PROGRAM—PAYMENTS TO FARMERS**

We would expect that the normal tenant-landlord agreement will be applied with respect to the Special Canadian Grains Program.

*[Translation]***CANADA POST CORPORATION****OPERATIONAL PLAN—MINISTER'S POSITION**

**Mr. Alfonso Gagliano (Saint-Léonard—Anjou):** Mr. Speaker, my question is directed to the Minister responsible for Canada Post. According to the Canadian Press, the Minister stated that he does not believe the chairman of the Standing Committee on Government Operations that studied the postal plan intended it to give rural residents a veto on post office closures or changes to postal services as recommended in the unanimous report released March 23. Did the Minister meet with the committee chairman and, if so, what made him retract his unconditional support for this unanimous report?

**Hon. Harvie Andre (Minister of Consumer and Corporate Affairs):** Mr. Speaker, as I indicated yesterday, the recommendations of the report are already policy. The Hon. Member would know that if he read the letter that I sent to all Members. Under the Canada Post Corporations Act, which was supported by all Parties in this House, the Post Office has the responsibility to manage. I have indicated that I will guarantee that Canada Post will do that in a sensitive and a proper way and a way which reasonable people can understand, appreciate and agree with. That remains a commitment. If that remains at odds with what the committee recommended, then so be it. I have to fulfil my responsibilities.

**RURAL POST OFFICES**

**Mr. Alfonso Gagliano (Saint-Léonard—Anjou):** Mr. Speaker, can the Minister tell this House what the misunderstanding is? The committee report was unanimous. In clear language we find this is the report:

(a) that no closure of a rural post office or change in rural service be undertaken without meaningful consultation and the consent of the community affected.

How clear can it be? Why is the Minister playing with words and creating fear in the community?

**Hon. Harvie Andre (Minister of Consumer and Corporate Affairs):** Mr. Speaker, it is the Hon. Member and people like him who are creating fear. In the letter I wrote to the Hon. Member—and again I plead with him to reread it—I indicated that in the event of any change Members of Parliament will be the first to be told. There will be consultations with the people affected and the changes should be of the sort that reasonable people can agree to. I do not know how much clearer I can make that statement. It is just a repetition of what is in the letter. Why does the Hon. Member not read the letter?
