XXII. And be it Ordained and Enacted, that the Places of meetmeetings of every such Council shall be holden in ing to be apsome convenient place within the District to which pointed by the such Councils shall respectively belong; and it shall be Governor. lawful for the Governor of this Province, by his proclamation under the Great Seal of the Province in that behalf to be issued, to appoint and determine the place of meeting for every such Distaict.

XXIII. And be it Ordained and Enacted, that all acts whatsoever authorized or required by virtue of this Ordinance to be done by the Council of any of the said Disorder of votes. tricts, and all questions of adjournment or other questions that may come before any meeting of such Council, may and shall be done and decided by the majority of votes of the members present at such meeting, other than the Warden; and the Warden, or, in the absence of the Warden, the temporary Chairman, shall in all cases of equality of votes have a casting vote; and, in order to constitute a Quorum there shall be present at every such meeting a Quorum. majority of the entire number of Councillors elected to serve in such Conncil.

XXIV. And be it Ordained and Enacted, that minutes Clerk to keep of the proceedings of all meetings of the said Coun-minutes of procils shall be drawn up and fairly entered in a book to be ceedings of Council. kept for that purpose by the Clerks of such Councils, respectively, which minutes shall be signed at the close of every such meeting by the Warden, or temporary Chairman, who shall preside thereat; and the said minutes shall be open to inspection by any elector of the District at all seasonable times on payment of a fee of

XXV. And be it Ordained and Enacted, that it shall be lawful for each of the said Councils to appoint, from and appoint Comout of the Councillors elected to serve in such Council, such and so many Committees, consisting of such number of persons as they may think fit, for any purposes which in the discretion of such Council would be better regulated and managed by means of such Committees; but subject in all things to the authority, controul, and approval of the said Council.

XXVI. And be it Ordained and Enacted, that from and out of a list of three fit and proper persons to be submitted by each of the said Councils to the Governor of this Province it shall be lawful for the said Governor to select one to be and be called the District Clerk; and every such Clerk shall be appointed by an Instrument to be issued under the Great Seal of this Province, and shall hold his office during pleasure: Provided always, that if at the first meeting under this Ordinance, or at the next quarterly meeting after any vacancy shall have occurred in the Office of District Clerk, or at any extraordinary meeting to be called for the purpose of filling up such vacancy, any such Council shall fail to agree upon the three names to be submitted as aforesaid to the said Governor, then it shall be lawful for the said Governor to appoint some fit and proper person to be such Clerk.
