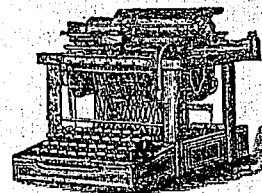

MR. R. T. HENEKER, L.L.B., this city, late of the legal firm of Wotherspoon, Heneker & Lafleur, has been appointed assistant Solicitor to the Canadian Pacific Railway Company.

When Elzéar Fiset, boot and shoe dealer, Quebec, recently assigned in trust to one of his creditors, it was thought the estate would pay 40 cents in the dollar, but Fiset's landlord has seized his stock in trade, and it is now being sold out by sheriff.

IT MAY BE necessary to remark that the Mutual Insurance Organization which issued the following notice to members is not located in the Emerald Isle: "In the event of your death, you are requested to bring your book, policy and certificate at once to Mr. —, when your claim will have immediate attention."

No HESITATION was shown in accepting 50 cents in the dollar offered by Mitchell Bros., grocers, of Kincardine, Ont., whose assignment, on the 21st ult., we noticed last week. Payments are to be made in 6, 12 and 18 months, secured by endorsement. The firm commenced business three years ago with a cash capital of \$700, and are said to be attentive to business. Their failure is owing to loss by fire and to difficulty of getting in accounts. Liabilities \$3,400; assets \$3,000 in stock and book debts,
