REPORTED U.S. PRESSURE TO REDUCE IMPORTS FROM CANADA

#### On the orders of the day:

In view of the repeated press reports of pressure being exerted on the Canadian government by the United States government to curb the growth of oil imports from Canada into the United States, can the minister assure the house that these oil exports to the United States, which are so necessary to Canada's economy, will be continued?

Hon. Jean-Luc Pepin (Minister of Energy, Mines and Resources): What I can say is that conversations between Canada and the United States regarding oil are now in progress, and each side is pressing its views with vigour.

**Mr. Eldon M. Woolliams (Bow River):** I have a supplementary question, Mr. Speaker. In view of the importance of the question and the minister's answer will he be prepared to made a full statement in the house with regard to the government's policy on petroleum, if it has a national policy at the present time?

**Mr. Pepin:** Mr. Speaker, I think I can make it now. Our policy is to sell as much as we can in the United States, which is part of the national oil policy.

Is it a fact, as reported in the press, that the R.C.M.P. has advised the attorney general's department of Ontario that there is sufficient evidence to indict Banks for perjury, and that the R.C.M.P. has laid or is about to lay the necessary information to start the wheels of justice turning?
