UNEMPLOYMENT—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, I ask leave of the House under Standing Order 43 to present a motion. I do so because of the many people across Canada who are making statements about the critical unemployment situation and the desirability of having some of these people appear before the Standing Committee on Labour, Manpower and Immigration so that we can get the picture and come to grips with the problem. UNEMPLOYMENT—DESIGNATION OF ONE MINISTER
TO CO-ORDINATE DEPARTMENTAL POLICIES
AFFECTING ECONOMIC CONDITIONS

Hon. George Hees (Prince Edward-Hastings): I would like to direct a question to the Acting Prime Minister. As the policies of six departments—the Department of Finance, the Department of Industry, Trade and Commerce, the Department of Regional Economic Expansion, the Department of Transport, the Department of Consumer and Corporate Affairs and the Department of Manpower and Immigration-largely determine the condition of the Canadian economy and consequently the level of employment in the country, has the government given consideration to designating one minister, preferably the Minister of Finance, to co-ordinate the policies of these six departments as they affect general economic conditions in the country so that a co-ordinated and more effective attack may be made on the problem of unemployment?

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, the hon. gentleman has been a member of cabinets in the past and he knows that the best way of co-ordinating government policy is through the cabinet itself. Many countries have tried the experiment of appointing super economic ministers and invariably they have failed. I do not think it is a useful precedent.
