2. The reply, dated February 16, 1970, acknowledged receipt and informed Mr. Bonnar that his presentation had been noted and

was being brought to the attention of the Minister of Regional Economic Expansion.

3. Yes. (a) The Minister wrote to Mr. Bonnar on April 6, after receiving a report from the Cape Breton Development Corporation. (b) The reasons for the pre-retirement plan were explained.
