REQUEST FOR IMMEDIATE REINSTATEMENT OF FULL NAME ON "K" DIVISION HEADQUARTERS BUILDING, EDMONTON

Mr. Douglas Roche (Edmonton-Strathcona): Mr. Speaker, my question arises out of the previous reference to the RCMP and is directed to the Solicitor General. Bearing in mind the strong reaction throughout western Canada against changing the designation of the Royal Canadian Mounted Police, will the minister order the immediate reinstatement of the RCMP name in a size big enough to be seen on "K" division headquarters in Edmonton, which only yesterday reported having received no directive yet?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, I should point out that there was never any intention to change the name of the Royal Canadian Mounted Police.

Some hon. Members: Oh, oh!

Mr. Allmand: Certainly I have no intention of changing the name. With respect to the signs on buildings, the RCMP is now consulting with the Attorneys General of the different provinces where the RCMP act as provincial police to see what kind of sign is most suitable in the provinces. As soon as those consultations are concluded the new sign will be installed.

Mr. Roche: Will the minister bear in mind that the prolonged delay in restoring the full designation of the RCMP is a continuing source of public friction and concern in this centennial year of the RCMP?

Mr. Speaker: Order, please. That is a representation or debate and I do not think the matter should be pursued.
