CFB FOYMOUNT—REFUSAL TO ALLOW ACCESS TO PERLEX INTERNATIONAL CHEMICALS LTD.

Question No. 2,027—**Mr. Reynolds:**

1. Did CADC officials refuse to allow access to the CFB Foymount facility by the Perlex International Chemicals Ltd. auditing team?
2. Was the refusal in keeping with CADC regulations?

Hon. Jean-Pierre Goyer (Minister of Supply and Services): In so far as Crown Assets Disposal Corporation is concerned: 1. At no time did any official of CADC refuse access of representatives of Perlex International to visit the Canadian Forces Base Foymount.

2. In accordance with the Corporation's invitation to bid, prospective bidders are requested and instructed to inspect all material offered for sale prior to submitting an official bid.

CFB FOYMOUNT—DIFFICULTIES EXPERIENCED BY COMPANY 260303 HOLDINGS LTD.

1. Prior to the sale of CFB Foymount, did the Company 260303 Holdings Ltd. experience any agreements of sale with CADC and, if so, what were such transactions?
2. Did the Company comply efficiently to former contracts awarded to the extent that there can be no complaint with their interaction with CADC?

CFDC—FINANCIAL ASSISTANCE FOR FILM "HOCKEY VS XOKKEN"

Did the Canadian Film Development Corporation refuse financial assistance for the film of the 1974 Canada-Russia series "Hockey vs Xokken" and, if so, for what reason?

Hon. James Hugh Faulkner (Secretary of State): I am informed by the Canadian Film Development Corporation as follows: No, but in 1973 it turned down a similar request from Arthur Harnett Enterprises Ltd., Communications Consultants, Toronto, on the grounds that the proposed film was not a feature film (i.e. having a running time of not less than 75 minutes intended for use in a motion picture theatre). The proposed changes in the CFDC's Act would permit such films to be financed.
