PART-TIME WORKERS

Question No. 238—Mr. Herbert:

1. What percentage of all persons employed are in part-time jobs?
2. How many do not work sufficient hours to qualify for unemployment insurance benefits?

Mr. Dennis Dawson (Parliamentary Secretary to Minister of Employment and Immigration): 1. Statistics Canada has reported that in 1979, 12.6 per cent of the employed labour force were part-time workers. Statistics Canada defines a part-time worker as one who usually works fewer than 30 hours a week and does not consider himself or herself a full-time worker.

2. Under the current rules for minimum weekly insurability, it is estimated that about 130,000 individuals who were part-time workers were prevented from establishing a claim in 1979.
