land. If that be the case, I should not object at all.

Hon. Mr. GIBSON-I move the suspension of rule 24.

Hon. Mr. DAVIS-I object to it.

The SPEAKER-Is there any objection to the suspension of the rule?

Hon. Mr. DAVIS-Yes.

Hon. Mr. GIBSON-Then I move that the report be taken into consideration tomorrow.

The motion was agreed to.

THE RULES OF THE SENATE.

Hon. Mr. LANDRY-I should like to know when we will be put in possession of the French edition of the rules of the Senate. That edition was prepared before we left Ottawa last summer and was accepted by this House.

Hon. Mr. YOUNG-Does the hon, gentleman refer to the report of the special committee appointed to revise the translation?

Hon. Mr. LANDRY-Yes. They reported and their report was accepted on the last day of the session. I take this opportunity to ask if we could not also have a copy of the rules of the House of Commons for each member of the Senate. Their rules have been changed and the old rules with which we are now supplied are no longer of any use.

Hon. Mr. SCOTT-The request is a reasonable one, and attention having been called to it I will see that it is complied with. I am advised that the rules are not ready for distribution, but I will see that they are. The Senate rules, I understand, have been in print for some time; I do not know why they have not been bound and distributed. Very often at the Printing Bureau they wait until some one gives a direct order, what they call 'approving of the translation.' I shall make inquiry about it and see that it is done.

Hon. Mr. De BOUCHERVILLE-I would suggest that copies of the rules of the Senate be distributed to members of the House of Commons.

The Senate adjourned until to-morrow at 3 p.m.
