EXTERMINATE THE PUGS.

In a late issue of the Canadian Sportsman, Mr. E. King Dods, the well-known horseman and licensed victualler, champion, has the following editorial under the heading of "Exterminate the Pugs."

"Subsequent reports of the so-called fight between Corbett and Sharkey tend to prove that the whole affair was pre-arranged, and it is not surprising that the big crowd of better class people present were disgusted. Yet, I feel inclined to say that it served them right. If men are fools enough to give up all the way from ten to fifty dollars for an admission ticket to such entertainments, they are brilliant illustrations of the truth of the declaration that 'fools and their money are soon parted,' the sort of game played on them at the Lenox Club is just the same. The short-haired fraternity prefer to serve up, and if it serves to sicken the fools who paid such fancy prices it will do ultimate good.

"The present generation of fighters are great mouth performers in more ways than one. They possess the courage of a Bayard, the cunning of a Mace, and the brilliant fighting qualities of a Heeman—in their mind—and their open mouths continually proclaiming the fable is unfortunately allowed to echo all over the continent through the columns of the daily press. If the newspapers would but deal with them on their merits, the public would hear little to their credit; but now the boozings of Sullivan, the escapades of Corbett, the freakish performances of Fitzsimmons, the mad pranks of Danster, and the daily doings of a hundred other 'pugs' are chronicled as if of vast public importance, hence, a spurious reputation is built up for them, and a gang of loafers, too lazy to work

and too proud to beg, are kept clothed in purple and fine linen, and appetites that used to be satisfied with cheap beer now clamor for 'fiz,' and have the superb insolence to pronounce judgment upon the quality of different brands.

"Men from the very dregs, spawn of the alley and froth of the gutter, turn to pugilism because it is an easy way by which to secure a living, and the foulest-mouthed scamp that ever filled the role of bar-room loafer, can secure a following if he has his hair cut short and can puff his own fighting abilities loud enough. If he but keeps on yelling long enough and loud enough, some reporter of a daily paper will interview him, and he will speedily secure the notoriety necessary to bring the dollars rolling in. If he will but unoffendingly drink, knock down an unoffending citizen or two and smash the furniture of some popular drinking place all the better, he will secure a column or more descriptive of his prowess, and though it rarely happens if he get fined for his rowdiness—it will only be an additional advertisement in his favor.

"Papers like the Cincinnati Enquirer, having immense circulations and that charge very high advertising rates, and who will value a reading notice for a legitimate business enterprise at about a dollar a line, will give hundreds of lines gratis to describe the personal appearance and penchants of pugilists, some of whom are too beastly and too disreputable to be recognized by decent people. If the press would but leave them severely alone, stop chronicling their movements, and treat them the same as they do the general public, the gang would be extinguished in six months. In no other country in the world could fighters of the calibre of Corbett and Sharkey draw a \$50,000 house as they did in New York the other night, and it is by no means a creditable illustration of our boasted modern civilization that low, loud-mouthed, boastful pugs, one of them of particularly unsavory reputation, could draw more gate money than could be taken in a whole week of six performances for the highest class entertainment that modern art or science could supply. Philosophize as you may and prattle as many distinguished men do, shout the intellectual age in which we live, and the superior morality that distinguishes the present generation, such facts as the above smashes into fragments all such theorizing. It will now be in order for Sharkey and Corbett to go on the road with a variety, each express his willingness to fight any man in the world for any amount of money, and the green gullible public will swallow it all and ask for more.

"The only satisfactory thing in connection with the late thieving match is that the New York daily papers appear to have at last opened their eyes to the true character of the gang that have for so long been playing the flim-flam game on the great American public. Not one of them but admits that the whole affair was a rank swindle, engineered by a few bold operators, and the prize being the \$50,000 or more dollars of the gullible public. Not one dollar of stake money was put up, there was a general divide all round, and the interference was a part of the prearranged programme. The New York World declares that its sporting editor was told six days before the fight by M. B. Gray, manager of 'Kid' McCoy, that the fight would not last more than twelve rounds, and that—Sharkey would be given the decision either on foul or by some other tactics. It is also stated that proof can be obtained that telegrams were sent from New York telling certain parties to get down on Sharkey, as everything was made certain. Be that as it may, the public have been deliberately swindled out of a large amount of money, and it will be a long time before another so-called fight will attract many people to New York. The old-fashioned tread-mill would be a

proper dose to prescribe for modern pugs of the Corbett stamp."

MUSIC HALL BADLY BURNED

The Rear Part of the Building Wrecked.

Manager Arthur and His Company Heavy Losers.

Firemen Do Good Work Under Great Difficulties—Total Loss Estimated at \$10,000.

All that now remains of the Music Hall is charred walls and a heap of water-soaked ruins. The damage, it is estimated, will reach \$10,000. About 12:45 P. C. Nelson Smith, who was on duty on King street, near Wellington, was the first to notice the flames as they shot against the back windows of the second story. An alarm was at once given, but before the firemen arrived on the scene the flames had begun to consume the Music Hall stage, the southwest end of which was soon a seething furnace, from which tongues of fire and volumes of smoke ascended. The flames licked up everything in their path, and burst through the roof before a drop of water had been thrown into the burning building. By vigorous efforts the fire was kept within the walls of the theater, and was gotten under control after an hour's hard fighting with six streams.

The blaze is supposed to have started in the dressing-rooms, and most of these, together with their contents, were totally destroyed.

When the fire once got into the theater it spread rapidly. The contents were consumed or so damaged as to be valueless, and the roof was literally burned to charcoal, and fell in upon the theater floor.

The front portion of the building, that occupied by the Conservative Club, was unharmed. The water, however, did considerable damage to the premises of R. R. Bland, which are directly beneath the theater. He calculated that at least \$500 damage was done to his stock of grates and mantelpieces.

The building is owned by Mr. Alex. Harvey, who says he is fully covered by insurance.

IN HARD LUCK.

A few days ago the hall was leased to Mr. W. C. Arthur, of Ottawa, until May 1, for theatrical purposes. The company was composed of fourteen people, and were to give a performance every evening, and three afternoons, each week, but what they will now do is not yet known. Nearly every member of the company lost about all they possessed in their professional line. Harry Delane, change artist, had a costly collection of dresses; he carried 200 pounds of excess baggage, and the whole of his wardrobe is ruined. The contortionists, Johnson and McKay, also lose a costly wardrobe, their bodies being filled with water and partly burned. Alvino, the canjo juggler, lost all his instruments and all his stage paraphernalia. Kent and French, the Irish comedians, and Welch brothers, who did the rough act, escaped the lightest of them all. The loss to actors and actresses will total up \$2,000 easily, according to Mr. Arthur.

Mr. Arthur this morning said it was a case of hard luck. On Nov. 28 he was to have opened for the season in Ottawa, but on Nov. 27 the theater was burned, together with most of the company's property. Just what he will do he has not yet decided. The company, which has suffered so greatly, was one of the best vaudeville combinations on the road and was highly spoken of. A benefit is suggested to aid those who lost all to replace their wardrobes.

FIREMEN'S GOOD WORK. Too much cannot be said of the efforts of the fire brigade. The fire had

gained great headway before they had a chance to get at it, and to get at it meant to encounter many difficulties. The sleet and ice on everything made their task a dangerous one, but they succeeded in their efforts to extinguish the flames without accident.

WESTERN ONTARIO

St. George Farmer Accidentally Shot By His Companion.

Windsor Custom Officers Make a Seizure—Chatham Minister Charges a Constable With Assault—Two-Year-Old Child Badly Scalded.

E. A. Burke, of Alveston, has been appointed a notary public. A hearse upset at a funeral in Brantford on Sunday, and was badly smashed.

Henry Tofflemire, of Leamington, who was accidentally shot while hunting, is dead.

The customs officers at Windsor on Sunday relieved a man of two storm jackets he was smuggling.

The postoffice at Stevensville was robbed on Saturday night and \$7 or \$8 worth of stamps were stolen.

James McMaster, eldest son of D. McMaster, merchant, Sarnia, died on Monday after several months' illness.

Father M. J. Brady, of London, will assist Fathers Flannery and Scanlon during the holiday services in St. Alphonsus' Church, Windsor.

Secretary Black, of the board of education, Windsor, has received \$215 from the Ontario Government, a grant for the inspection of Windsor's schools.

The Exeter council has granted exemption from taxes for ten years to the Sutherland-Limbs Company, who intend operating an extensive saw mill in that place.

A natural gas explosion at Leamington caused a fire which badly damaged Ludlam's saw and door factory. Loss will aggregate several thousand dollars. One employee was seriously burned.

The wires of the G. N. W. Telegraph Company, which were broken during the storm of Dec. 3 and 4, have been repaired, and business has been resumed between Leamington and Amherstburg.

Nominations for county council division 7 were held at Sandwich Monday afternoon. Noe Dufour, Joseph De-rocher and Hypolite Mailloux are the only candidates who have been prominently mentioned.

Mrs. Julia E. Marantette, of Windsor, and Bernard C. McCann and Geo. O'Neil, of Sandwich South, have passed the governmental qualifying examinations fitting them for positions in the postoffice service.

The 2-year-old child of Mr. and Mrs. E. I. Brown, of Ridgetown, tripped, and fell into a painful scalding water, on Sunday afternoon, burning one leg and part of the body badly. Dr. McFarlane dressed the wound.

Mrs. Nellie Stovey died at Port Stanley Sunday from the effects of lung trouble, aged 15 years. Deceased was the eldest daughter of the late Wm. Stovey, of Bothwell. The funeral took place to Union cemetery.

Mr. W. Papple, a young farmer residing on the Governor's road, near St. George, was accidentally shot and injured while out hunting on Saturday by his companion, named Drake. Papple's injuries are serious, though it is hoped not fatal.

Miss Maud Shaw, who has been engaged to teach the junior department of the Tilbury public school for 1899, has been awarded the W. Grey & Son's (Chatham) silver medal, for acquiring the highest standing in the second-class certificate grade at the Chatham College for the year.

Lawrence Roelstons, a well-known resident of Brant county, near Mount Pleasant, died very suddenly Sunday. Deceased visited the Brantford market on Saturday, and while there he was seized with a paralytic stroke, and had to be removed home, where medical aid was summoned, and the old gentleman rested easy and seemed much better. On Sunday, however, he suddenly passed away. Deceased was 81 years.

Customs Officers Drullard and Yearsley, of Windsor, made a seizure Saturday that surprised them after they had taken an inventory of the goods. The officers for some time have suspected Mrs. Stein, living in Windsor. When they saw her she was searched and about 100 yards of prints, several house wrappers, a number of men's hunting coats, ladies' and gents' underwear, table-covers and bed-spreads were discovered on her. The articles were confiscated and the woman promised to settle with the government.

Rev. G. L. Blake, the lately deposed pastor of the U. A. M. E. Church at Chatham, has laid an information against Constable J. J. Thompson, charging the officer with having assaulted and beaten him on Sunday, the 4th inst., while attempting to discharge his duties as pastor in the pulpit. Of-fer Thompson pleaded guilty to having made an assault, but denied the latter part of the charge. Bishop J. C. Wilmore was called by Officer Thompson, and testified that he was the bishop of the church, and had forbidden Mr. Blake preaching. The bishop produced the discipline of the church to show his powers, and said that he deposed Rev. Mr. Blake for misappropriation of funds. "I ordered the officer to take Blake out of the pulpit, and the officer used no force," said the bishop. Case adjourned until Dec. 27.

THREW THE PLATE

Sequel to the Sensational Affair in St. Thomas.

Statement of the Dead Man's Mother—Threatened to Kill the Family—An Act of Self-Defence.

The St. Thomas Times has this to say of the Birdsall affair, described in another column:

"Mrs. Birdsall, mother of the dead man, was counseled by friends to tell all she knew about the case. Mrs. Birdsall decided to take that course, and she has made public the whole affair. She says that on Friday, Dec. 9, James came home drunk. He raised a row because supper wasn't ready, and in his anger picked up a hatchet. He grabbed one of the children by the hair of the head, and threatened to brain it. She interfered and took the children to a neighbor's. When she returned, deceased had his wife up against a door choking her. Mrs. Birdsall again interfered, and James again attacked her and threatened to split her head open with the axe. Charles Birdsall came to his mother's aid, and picking up a heavy plate hurled it at his brother. It struck James on the head, fracturing his skull. Mrs. Birdsall says Charles was compelled to do the act he did in order to save his life.

"After the reporter had left Mrs. Birdsall made a confession to Dr. Lipsey, stating that she was willing to tell the whole facts of the occurrence. On hearing this the reporter again called at the Birdsall residence and asked if the reported confession were true.

"Mrs. Birdsall stated she was willing to tell the truth to the proper officers, but they were both her boys and she did not want to say any more than was necessary. She, however, stated that her son had been struck by a thrown plate, but it was in self defense. 'He was crazy under the influence of liquor, and he attacked me in the corner with a hatchet,' she stated, but would add nothing more but the statement that Charles threw the plate in self-defense. She would tell the rest of the story at the inquest."

A Hint to Income Voters.

Another Appeal for a School of Domestic Science.

To the Editor of The Advertiser:

Having been prevented by illness from attending the meeting held on Friday, Dec. 16, in behalf of domestic science, I take the liberty of asking for space in your valuable paper to make one more appeal to the citizens of the Forest City for their daughters. It is a question that has never before been considered it should. Teachers of cookery, and women who have advocated it, have been considered fanatics, and have too often been met with, "Oh, every girl knows how to cook!" Yes, perhaps they do, but could you take a look at I have often heard some of those homes, you would very soon alter your opinion. It has been my privilege for the past five years to have traveled over most of Canada, and a great deal of the Eastern States, giving public lectures on cooking, and I have been surprised how many people come to me and say, "Do you really think the time is ever coming when our daughters will have the privilege of learning to cook in the public schools?" I have often thought, as I visited the beautiful model farm at Guelph, that if so much money is expended by the government to fit our sons to be good practical farmers, why are our daughters lost sight of entirely? To be sure, there are training schools for cookery, but the expense is beyond the reach of most girls. The W. C. T. U. of this city are doing a good and noble work in their industrial school. It was my privilege for some time to teach the cooking class in connection with it, and I do not think I have ever enjoyed anything as I did that work. One of the great difficulties in getting our girls to cook and take up housework, is they think it is degrading, and they cannot be neat and clean while about it. What a mistake! The very highest place God ever intended for a woman was her home. How can she make a home unless she be a good, clean, neat, economical cook and housekeeper? Many a man would be saved from a drunkard's grave if his wife knew how to make the very best of what he provided for her.

If I had a home the kitchen would be the very brightest room in it. I would not be very careful whether I had a parlor to receive company in or not, but I should have a clean, bright kitchen. Good, wholesome, plain food, properly cooked, is what we need. For a long time I have felt that London, with all her educational advantages, would see the need of a school of domestic science. With a mayor and a school board who seem to favor the scheme, what is to prevent the Forest City from establishing a school of cookery? MISS C. V. TWO BABES CREMATED

Child Left Alone Plays With Fire—Another Pulled the Lamp Over and Was Fatally Injured.

Montreal, Dec. 20.—A couple of fatal accidents by burning were reported to the coroner yesterday. The 3-year-old daughter of Mrs. Delphine Dignault, who resides at Outremont, was burned to death on Friday afternoon. The facts of the case as they were reported to the coroner were that while the mother was out of the house getting a pail of water the little one amused herself with playing with the fire in the kitchen stove. In some way her clothing caught, and before the mother returned the little girl was so badly burned that death resulted.

The second case was that of a 4-year-old child of Adolphe Rochon, Joiner, who was burned to death by upsetting a coal oil lamp. It seems that the little fellow was playing in the room where his father and mother were sitting. He accidentally pulled the lamp from the table, and the burning oil saturated his clothing. Before the parents could extinguish the flames the little fellow was badly burned that he died from his injuries.

TOLSTOI'S SON

Is in Charge of the First Party of Doukhobors En Route to Canada.

Montreal, Dec. 20.—The Beaver Line steamship Lake Huron, which sailed for St. John, N. B., from Batoum, on Dec. 16, has on board 1,322 persons. In charge of the party, according to the Canadian Gazette, is Count Serge Tolstoi, son of the world-famous idealist and author, Count Tolstoi. Mr. Soulergitzky, whose name is now familiar in connection with this movement, will conduct the party on board of the steamship Lake Superior, the next steamer. The party of Doukhobors will proceed directly from St. John to Winnipeg.

FINED FOR STRIKING A WOMAN.

Barrie, Dec. 20.—Frank Cooper was yesterday fined \$15 and costs for striking a young woman on the street, blackening her eye.

CARPENTERS WANT AN ADVANCE.

Winnipeg, Dec. 20.—Union carpenters have decided to demand 20 cents an hour and a 9-hour day after May 1 next.

TRIED TO HANG HIMSELF.

Winnipeg, Man., Dec. 20.—Czuby, the Austrian, who killed five people at Stuartburn last October, is completely broken down. While en route to this city yesterday he represented his attempt to hang himself in the closet of the car. It is said his confession implicates another man.

PROFITS OF THE INDUSTRIAL.

Toronto, Dec. 20.—The auditors' statement shows that the total receipts of the Industrial Exhibition this season amounted to \$116,616 95; the disbursements to \$60,540 83; leaving a profit, as the result of the exhibition of 1898, of \$26,135 02. Last year the receipts amounted to \$94,557 22, there being a loss of \$2,561 90.

NEW PULP MILLS ON THE GATINEAU.

Ottawa, Dec. 20.—Hiram S. Maxim, of London, England, inventor of the famous Maxim gun, is here in connection with the proposed establishment of pulp and paper mills on the Gatineau. Maxim represents British capitalists who have plenty of capital to develop the pulpwood resources of the Gatineau district, and who have faith in the resources. Mills will be erected larger than any near Ottawa.
