\$3,000,000 FIRE LOSS IS LAID TO SMOKERS

Annual Cost to State of Tossing Away Lighted Butts and Matches—Average for Five Years.

The tossing away of lighted cigarette and cigar butts and lighted matches costs the New York state more than \$5,000,000 a year, according to a detailed analysis of the causes of fire in this city during the five years from 1915 to 1920 by the National Board of Fire Underwriters.

The total destruction of property by fire during that period was \$164,425,819. Most of this loss was due to preventable causes and is represented as the price paid for public ignorance and carelessness in handling fire hazards.

Smoking and tossing away lighted matches or butts was the most prolific cause of "strictly preventable" fires, the list of losses from "strictly preventable" causes being as follows:

The losses from causes designated "partly preventable" included an item of \$27,465,791 from "exposure," which means losses when a fire in one building spreads to one or more additional buildings. The other losses from these causes were as follows:

The losses from unknown causes were \$82,226,085. The statement of the underwriters continues:

"New York state lost more than \$3,000,000 a year from the amount of loss by fire, and the figures quoted should be increased by about twenty-five per cent. to cover losses not reported to the National Board of Fire Underwriters.

A study of such figures indicates the need of public education in fire prevention. It should be realized that property destroyed by fire represents an utter irretrievable loss to the people as a whole, while the inexcusable toll in human life and suffering can hardly be computed.
