

J.P. Has held the office of Postmaster. First returned to Ho. of Assem. at g.e. 1882. Unseated for holding office while in the Ho. and re-elected April 1883. Re-elected at last g.e. A Liberal.—*Campbreton, Lot 4, P.E.I.*

MCLEAN, JAMES R. (*King's, 1st Dist.*)

Grandfather, Charles McLean, emigrated from North of Scot. about 1800, lived for a short time at Charlottetown, but finally settled at East Point, 1805. B. at East Point, 9 April, 1842. Ed in P.E.I. M., Nov. 1870, Mary Armstrong, dau. of Hon. Joseph Wightman, M.L.C. A merchant. Has been a Governor of Prince of Wales' Coll. Was a mem. of the Ex. Council 1872-3, and sat at the Board of Works and at the Board of Education. An unsuccessful candidate for King's in Commons, Sept. 1873. First returned to Ho. of Assem. 1869, and continued to represent 1st Dist. of King's until g.e. 1879, when he was defeated. Re-elected at g.e. 1882, and again at last g.e. A Liberal.—*Souris*.

MCLEAN, JOHN. (*King's, 1st Dist.*)

Of Highland Scotch descent. S. of Daniel and Sarah McLean. B. at Mount Herbert, Queen's Co., 1846. M., 1852, Maltida Jane Jury, of Charlottetown. Is a mem. of the firm of Matthew McLean & Co., general merchants. First returned to Ho. of Assem. at g.e. 1882, and re-elected at last g.e. A Conservative.—*Souris East, P.E.I.*

MCLEOD, ANGUS. (*Kings, 4th District.*)

Forefathers came from the Scottish Highlands. B. at Valleyfield, P.E.I., 1845, and ed. there. M., 1871, at Georgetown, Jessie McDonald. Was a school teacher for 15 years, but is now engaged in farming. First returned to the Ho. of Assem at last g.e. A Conservative.—*Brown's Creek, P.E.I.*

MCLEOD, NEIL, M.A. (*Charlottetown and Royalty.*)

Of Scottish parentage. B. in P.E.I. 15 Dec., 1842. Ed. at Wolfville, N.S., and is a graduate of Acadia Coll., N.S. M., June, 1877, Adelia, dau. of James Hayden, Esq., of Vernon River, P.E.I. Called to the Bar P.E.I., 1872. First returned to Ho. of Assem. for present seat at g.e. 1879. Sworn of the Ex. Coun., and Provl. Secretary and Treasurer, 11 March, 1879. Resigned his portfolio 3 March,
