The lectures on Real Property, and Practice and Procedure will embrace one-fourth of the total number of lectures, and will be delivered

by a lecturer.

The lecturers on Equity, Commercial Law, and Evidence, will embrace one-fourth of the total number of lectures, and will be delivered by a lecturer.

GENERAL PROVISIONS.
