REQUEST FOR REVIEW OF EXPENDITURES

On the orders of the day:

Mr. Colin Cameron (Nanaimo): Mr. Speaker, I wish to direct a question to the Minister of National Defence. In the light of the reported statement of Lieutenant General Guy Simonds, former chief of staff, that at least 80 per cent of our present defence expenditure is totally wasted, can the minister assure the house that he and his officials are engaged in a serious and realistic appraisal of Canada's defence position, and is he now prepared to recommend to his colleagues that a committee of the house be set up to investigate the situation?

Hon. G. R. Pearkes (Minister of National Defence): Mr. Speaker, I can assure the hon. member that I and the officials of my department have been making a very careful and realistic study of the problems to which he refers.

Mr. H. R. Argue (Assiniboia): Mr. Speaker, I wish to direct a supplementary question to the minister. In the light of recent international developments, has the Department of National Defence reconsidered the decision to continue with the development of the CF-105?

Mr. Pearkes: The decision was taken the other day to continue with the development of the CF-105 for another year because we believe that in the foreseeable future, if any threat from the air develops against this country the manned bomber will be at least an important part of that threat, and therefore we must have a manned interceptor capable of firing air missiles which will have a homing ability, enabling them to direct themselves on the target. We believe that to be essential.
