STEPS TO MEET URANIUM DEMAND

Question No. 345-Mr. Caouette:

Has Eldorado Mining and Refining Ltd. taken any measures to fill the increasing demand for uranium and, if so, what are they?

Mr. Jack Davis (Parliamentary Secretary to Minister of Energy, Mines and Resources):

In the past year Eldorado Mining and Refining Limited has increased its annual uranium production from the Beaverlodge mine by 11 per cent and is bringing into production a new 250 ton per day mine located some eight miles from its present mining and milling operations.

Through press releases and annual reports, the corporation has repeatedly warned the Canadian uranium producers and the mining industry at large of the urgent need for increased exploration and development of new uranium deposits to meet the increasing world demand.

INCOME TAX PAYMENTS

Question No. 356-Mr. Davis:

- 1. What were the personal income tax payments to the federal government in total and on an average per capita basis, by province, for the fiscal year 1964-65?
- 2. What were the corporate income tax payments to the federal government in total and on an average per capita basis, by province, for the fiscal vear 1964-65?

Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board): 1. Personal income tax payments to the federal government in total for the fiscal year 1964-65 were \$2,903.9 million. The total includes old age security tax and provincial income tax collected by the federal government. Collection figures by provinces are not available because payments and refunds processed by the taxation data centre in Ottawa in 1964-65 relate to all provinces and district office collection figures, therefore, do not indicate correctly the amount collected in each province. The following table, based on an analysis of tax returns, shows the total tax payable by individuals in respect of the 1964
