6. Statistics are not maintained of the total sum of pensions paid in federal constituencies. It is estimated that on March 31, 1968 there were 138,000 veterans resident in the Province of Quebec. The annual liability for disability pensions payable to veterans resident in Quebec on March 31, 1968 is estimated at \$24,808,500.

Question No. 1,084—Mr. Fairweather:

At what approximate date does Canada intend to establish a mission in Zambia?

Hon. Mitchell Sharp (Secretary of State for External Affairs): No date has been set for the opening of a Canadian mission in Zambia, Mr. Speaker. The current commitments for the extension of Canadian representation abroad, particularly in Francophone countries, have strained the personnel and financial resources of the Department of External Affairs. Nonetheless, the opening of a resident mission in Zambia retains a high priority.
