HIJACKING—RATIFICATION OF CONVENTIONS— AMENDMENTS TO CRIMINAL CODE

Mr. Mark Rose (Fraser Valley West): Mr. Speaker, my supplementary question relates to the previous round of questioning regarding air piracy and hijackings. I understand that Canada intends to ratify both The Hague and Montreal conventions on this subject. Since the Canadian ratification of these two conventions depends upon amendments to the Criminal Code which we were promised about one year ago would be brought forward in the immediate future, may I ask the Minister of Justice when these particular amendments or appropriate amendments will be coming forward.

Hon. John N. Turner (Minister of Justice): Mr. Speaker, domestic legislation not only depends on multilateral treaties; it also depends on the ratification of bilateral treaties with the United States, Cuba and other nations. When that treaty picture is completely in place, domestic legislation will be immediately forthcoming.

AIR PIRACY—DATE OF COMPLETION OF EXTRADITION TREATIES

Mr. Doug Rowland (Selkirk): Mr. Speaker, my question is for the Secretary of State for External Affairs. Since the Minister of Justice has indicated that amendments to the Criminal Code are dependent on the successful completion of multilateral and bilateral treaties, can the minister indicate to the House when he expects those treaties to be successfully concluded.

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, so far as the treaty between Canada and Cuba is concerned, we expect that it will be forthcoming fairly soon. The second and, I hope, final round will take place very soon. Perhaps I ought to explain to the House that it is quite possible to take legal action under the existing extradition treaty between Cuba and Canada; it does not depend upon any future treaty.

CANADA-UNITED STATES AUTO PACT—POSSIBLE REMOVAL OF SAFEGUARDS—CONTINGENCY PLAN TO COUNTER DISC PROGRAM

Mr. H. W. Danforth (Kent-Essex): Mr. Speaker, may I direct a question to the Prime Minister. It has to do with negotiations taking place on the automobile trade pact between Canada and the United States and is based on the statement by the right hon. gentleman that perhaps the United States is justified in asking for some amelioration of the safeguards and the statement of the Minister of Industry, Trade and Commerce in the House that perhaps the auto industry does not need such safeguards.
