2. As of this date, how many acres of land have been secured by or on behalf of the Department of Transport by agreements with the owners?

3. What is the total expenditure to date that has been made on planning, development or for any other purpose connected with the establishment of said Airport?

Mr. John M. Reid (Parliamentary Secretary to President of the Privy Council): I am informed by the Departments of Transport and Public Works as follows: 1. Yes.

2. None.

3. The total expenditures to date, December 31, 1972 for the planning and development of Toronto area airports is \$4,028,000. This amount covers all of the investigatory work which has been undertaken in connection with the planning of the Toronto area airports system. In the course of these investigations, many sites were examined, and it would have been impracticable to maintain separate accounting systems for each site. Expenditures in connection with the Pickering site are therefore in the figure of four million. No money has as yet been spent on the development of the Pickering airport.
