#### REFERENCE OF CANADIAN RADIO-TELEVISION COMMISSION REPORT TO COMMITTEE—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. Jean-R. Roy (Timmins): Mr. Speaker, I rise under the provisions of Standing Order 43 to seek unanimous consent to present a motion on a matter of urgent and pressing necessity. Because of the grave and extensive consequences and implications that the CRTC report entitled "Radio Frequencies Are Public Property" will have on the Canadian Broadcasting Corporation and broadcasting in Canada in general I move, seconded by the hon. member for Labelle (Mr. Dupras):

That the House should refer the report in question to the Committee on Broadcasting, Films and Assistance to the Arts for its full study and recommendations, and that the CBC and CRTC should abstain from implementing the recommendations and decisions contained in the report before the committee completes its study and reports to the House of Commons.

## MARKETING OF FEED GRAINS—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, I rise under the provisions of Standing Order 43 to seek unanimous consent for a motion which I consider to be urgent and pressing. In view of the opposition of thousands of prairie farmers to the proposed removal of feed grains from the jurisdiction of the Canadian Wheat Board, as well as the concern of their organizations such as the wheat pools and the National Farmers Union, I move, seconded by the hon. member for Regina-Lake Centre (Mr. Benjamin):

That this House support the principle of orderly marketing and instruct the government to maintain the Canadian Wheat Board as the sole marketing agency for feed grains.
