Some hon. Members: Hear, hear!

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I am afraid I cannot comment on the preamble to the question. It is one upon which I am sure members of the NDP would be perfectly able to comment. But so far as the question itself is concerned, I would like to indicate to the House that having set up this board, and having asked various responsible citizens to act on this board, the position of the government is that we want to give it a chance to operate before trying to destroy its credibility in people's minds, as obviously members of the opposition are trying to do.

Some hon. Members: Hear, hear!

Mr. McGrath: In view of the fact that the Special Committee on Trends in Food Prices is now drafting its second report, and in view of the fact that five of the six recommendations in the first report have been ignored by the government to date, may I ask the Prime Minister if the government is prepared to inform the House, and consequently the committee, as to what its policy decision is with respect to the five recommendations contained in the first report so that the committee can get on with the second report?

Mr. Speaker: I am sure the hon. member will appreciate that he is inviting the Prime Minister or someone on behalf of the government to make a general policy statement. I doubt whether this can be done at this time. It should be done normally on motions. The hon. member for Oshawa-Whitby.

Mr. McGrath: By way of a further supplementary—

Mr. Speaker: Perhaps I might return to the hon. member in a moment. The Chair has recognized the hon. member for Oshawa-Whitby for a supplementary question.

Mr. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I have a supplementary question for the Prime Minister. In view of the fact that the government seems unwilling to put teeth in the Prices Review Board—

Some hon. Members: Oh, oh!

Mr. Broadbent: —given the continuing increase in the cost of living, would the Prime Minister at least give consideration to putting a cost of living clause on the \$40,000 a year salary of the chairman of the board so that she can continue to cope?

Mr. Speaker: Order, please. I doubt whether this question is in order. The hon. member for St. John's East is rising on a supplementary question. He will be recognized for that purpose, and will be followed by the hon. member for Brome-Missisquoi who also has a supplementary question.

ALLEGED OPPOSITION OF CHAIRMAN TO PRICE CONTROLS—POSSIBLE MEETING WITH PRIME MINISTER

Right Hon. P. E. Trudeau (Prime Minister): Having set up the board, the government does not intend, I repeat, to interfere in the operation of that board. I hope that it will be the will of parliament to give the board a chance to operate before prejudging its action, as it appears to be doing now.
