CALL FOR LEGISLATION RESPECTING UNION BARGAINING— MOTION UNDER S.O. 43

Mr. Otto Jelinek (Halton): Madam Speaker, I rise under the provisions of Standing Order 43. In view of the fact that the fragmentation of union power within each essential service sector contributes dramatically not only to airline strikes, as presently seems to be the case with Air Canada, but affects other essential services like the Post Office and so on, and because of this government's inaction in this regard causing an unprecedented 55,041,600 man-days lost as a result of strikes and walk-outs since the Finkelman report was tabled in 1974, which report recommended, among other things, sector bargaining, I suggest the time is long overdue to take some specific action other than to just hope, as the Minister of Transport (Mr. Pepin) said yesterday. That, of course, is not enough. Therefore I move, seconded by the hon. member for Lisgar (Mr. Murta):
