UNFINISHED BUSINESS CONTINUED.

It was moved by the Rev. C. H. Mockridge, seconded by the Rev. Canon Mulock,

That, while admitting the principle of classification of Missions, as stated in the proposed amendment to part of Canon XVI, it is the opinion of this Synod that no Clergyman should be deprived of any portion of the grant which he now receives from the Mission Board until said Board has made arrangements with his people to make up the loss which, by this action, he will sustain.

Moved, in amendment, by the Rev. C. Forest, seconded by R. T. Walkem,

That, while admitting the principle of classification of Missions, as stated in the amendment to part of Canon XVI, it is the opinion of this Synod that no Clergyman shall be deprived of any portion of the grant which he now receives from the Mission Board until the Archdeacon having jurisdiction over the section of the Diocese in which such Missionary is at work, certifies the Mission Board that arrangements have been made with the people of that particular Mission to make up the loss which the Missionary otherwise would sustain by any reduction on the part of the Board.—*Carried.*

R. T. Walkem moved, seconded by W. Ellis—

That the Report of the Committee on printing the Financial Reports be adopted.—*Carried.*

It was moved by the Rev. J. Stannage, seconded by the Rev. A. Spencer,

That the necessary expenses of the Clergy and Lay Delegates, incurred by attendance at Synod, be defrayed out of the Assessment Fund, and that the rate of Assessment be correspondingly increased.—*Withdrawn.*
