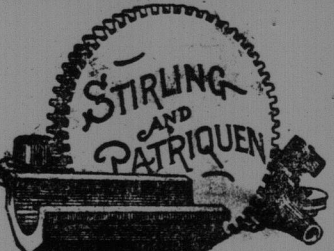

## CITY POST OFFICE

WILL BE MADE OVER.

Extensive Alterations Planned  
—Lobby Will Be Enlarged.

Money Order Department Will Be Moved  
Up Stairs and Made Accessible  
by Elevator—Other Changes

The postal department have under  
consideration at the present time some  
extensive alterations to the post office  
in this city. For some time it has  
been felt that the building here under  
the present arrangements was quite in-  
adequate. The lobby is small and nar-  
row and does not compare with the  
lobbies found even in some of the  
smaller towns through the province.  
The plan under consideration would  
make extensive alterations on the main  
floor. The money order department  
which is to the right when entering the  
main door, is to be removed to the  
second floor, while the space now oc-  
cupied by this department is to be added  
to the lobby, almost doubling its size.  
The number of post office boxes will  
be increased also by utilizing the par-  
tition between the addition to the lobby  
and the adjoining room.  
The money order department will be  
on the second story and will be made  
accessible from the main floor by an  
elevator from the lobby. This depart-  
ment will occupy the space now used  
by the inspector's department.  
The inspector's department will be  
transferred to the space now used by  
the caretaker, who will be furnished  
with apartments in the upper part of  
the building which is not now used.

## GENERAL MASSACRE OF RUSSIAN JEWS FEARED.

Another St. Bartholomew Said to be Planned  
For Saturday Night—Cronstadt Mutiny  
Quelled—Wild Rumors Alarm Peasants.

CRONSTADT, Nov. 10.—Apparently  
the mutiny here is entirely suppressed.  
The mutineers who were holding in the  
eastern section of the town have been  
arrested. The disorderly elements are  
under control.  
ST. PETERSBURG, Nov. 10.—During  
the rioting at Cronstadt the govern-  
ment treasury there, which was sur-  
rounded by a deep moat, filled with  
water was saved from the mob by the  
removal of the bridges.  
The United States consul general  
here received the following despatch  
from the consul at Cronstadt: "Soldiers  
aided by the mob commenced rioting  
here and several houses were set on  
fire and shops were robbed. The situ-  
ation remains critical."

Jews has been planned by the "Black  
Hundred" of St. Petersburg for Satur-

## SUIT CASE MURDER BEFORE GRAND JURY

Indictments Have Been Asked  
Against Four Persons.

Dr. Percy D. McLeod, Morris Nathan and  
the Two Men Who Disposed  
of the Body.

BOSTON, Mass., Nov. 10.—The case  
of Susanna A. Geary, of Cambridge,  
the chorus girl who died here as the  
result of unlawful medical treatment,  
and whose dismembered body was found  
at different times in suit cases in Bos-  
ton harbor, was submitted today to  
the grand jury. That body will be asked  
to report indictments against at  
least four persons, all of whom are  
now under arrest. They include Lewis  
Crawford and William Howard, who are  
held in New York, as the persons who  
disposed of the body; Dr. Percy D. Mc-  
Leod, a Back Bay physician, who was  
arrested on the charge of dismembering  
the body; and Morris Nathan, the girl's  
lover.  
About forty persons summoned to  
testify before the grand jury appeared  
in the court house today, and it was  
planned to conclude the case before  
night if possible.  
Nathan was among those subpoenaed
