**Hon. J. A. **EXTERNAL AFFAIRS****MAINLAND CHINA—PROGRESS IN NEGOTIATIONS  
REGARDING DIPLOMATIC  
RECOGNITION**

**Hon. George Hees (Prince Edward-Hastings):** Mr. Speaker, this question is for the Secretary of State for External Affairs. Has he anything to pass on to the house regarding the progress being made in the conversations which have been going on in Stockholm for some time now regarding recognition of Communist China by this country?

**Hon. Mitchell Sharp (Secretary of State for External Affairs):** Mr. Speaker, toward the end of last week there were further discussions on the outstanding issues. I cannot really say anything more about them except that the negotiations are tough and may continue for some time.

**Mr. Hees:** Mr. Speaker, could the minister advise the house what advantages the government believes will accrue to Canada, if we are permitted to recognize Communist China, that will make up for the humiliation this country has succumbed to for the past eight months?

**Mr. Speaker:** Order. The hon. member will recognize that if the minister is to reply it should be on motions and not by way of a reply to a question.

**Right Hon. J. G. Diefenbaker (Prince Albert):** Mr. Speaker, probably the minister would be able to clarify the situation in connection with the negotiations going on with Mao's representatives. Has there been any indication given, as rumour has it, that the Communist government of Red China is prepared to accept recognition provided Taiwan is sacrificed, and will in compensation purchase additional wheat rather than purchasing wheat from Australia which does not recognize it?

**Mr. Sharp:** No, Mr. Speaker, as far as I know the question of wheat has never entered into the negotiations on recognition.
