

Resolved, unanimously, That an Address be prepared to be presented to His Majesty and the Imperial Parliament on this all important subject, and that His Majesty's Legislative Council be requested to join in said Address; and further

Resolved, That a Committee of this House be appointed to join such Committee as the Legislative Council may appoint to prepare the same; and that a Committee be also appointed to acquaint the Legislative Council with this Resolution.

Ordered, That Mr. Partelow, Mr. Rankin and Mr. End, be a Committee of this House, to prepare the Address; and further

Ordered, That Mr. Partelow and Mr. Johnston be a Committee to acquaint the Legislative Council with the foregoing Resolutions.

Mr. Partelow, by leave, presented a Petition from I. W. M. Irish, of Saint John, Merchant, praying a return of Duties, paid at the Province Treasury, on sundry articles imported into Saint John from Nassau, New Providence, in March last, for the reasons therein stated; which he read.

Ordered, That the said Petition be received and referred to the Committee of Supply.

The House adjourned until to-morrow morning at 10 o'clock.

Mr. Partelow, by leave, presented a Petition from the Board of Health for the City and County of Saint John, praying that a grant may pass to enable them to erect a suitable Building on Partridge Island, for the accommodation of sick and distressed Emigrants; which he read.

Ordered, That the said Petition be received, and lie on the Table.

Mr. Hill, by leave, presented a Petition from Abner Hill and 48 others, Inhabitants of the County of Charlotte, praying an Act may pass to incorporate *The Saint Stephens Rail Road Company*; which he read.

Ordered, That the said Petition be received, and lie on the Table.
